        - (2) Everett's Atty, Rob Krauss presented a new lease. Dave Frenette denied this action. Review of the Restatement of Lease with 2 components
          - (a) Rent: \$893x625 students + 200,000 with start date of July 1, 2020. Atty is looking to move this start date to September 1, 2020
          - (b) "strike price" \$6.6M with October 15 purchase option.
          - (c) Landlord does not want to pay for cleaning of building

- (d) 4.4% increase in rent annually.
- (3) Trustees discuss lease and risk/expense.
- (4) Nick Christ motions to authorize New Heights (Omari Walker) to pay new facilities rate set by state (\$938) for 735 students and sign restatement of lease to begin on September 1, 2020 with lease to also include a strike price of \$6.6M. Motion seconded by Mike Sullivan. Discussion around draft terms to edit in lease, Centre Street.
  - (a) Amended: ED may negotiate up to \$15,000 in lease purchase in a way that is compliant to obligations under state law.
  - (b) general consensus 4 yes: 2 no
- (5) Motion to exit Executive Session. Motion seconded. Executive Session ended at 6:12pm.
- b) Rick motions to give ED authorization to negotiate a new lease agreement with Atty. Frenette. Stephan Bernard seconds the motion. No discussion. Motion passes 3 Yes: 1 no: 1 abstain.
